NARRATIVE

The 2023-2024 RCHS Campus Improvement Plan, encompassing grades 6 through 14, is based on student enrollment and demographic data.

Roscoe Collegiate High School is made up of Hispanic, Multi-Racial, White and African American student populations. Approximately 54% of students served are Hispanic, 40% White, 1% Multi-Racial and 4% African American. Approximately 40% of the students are eligible for free or reduced price lunches under the National School Program and 12% are limited English proficient (LEP).

Roscoe Collegiate ISD and surrounding schools are in a shared service arrangement with West Central Texas Shared Service Agreement who operates the special education program.

Roscoe Collegiate ISD is proud to note that our student body is served by an experienced staff with 13 having over 20 years of experience, 7 with 11-20 years of experience, 4 with 6-10 years of experience, and 15 with 0-5 years of experience.

Additionally, the district maintains a student-teacher ratio of approximately 9 to 1.

The high school uses multiple fund sources to support each of the educational programs. Through ongoing collaborative planning meetings between administration, campus administrators and the SBDM committee, needs are prioritized from the most current performance data in order to make decisions regarding where funds should be budgeted. The primary compensatory and other fund sources budgeted for 2023-2024 by the district include those in the attached budget listing.

The attendance rate for the high school is 95.24%. The drop-out rate for all students is 0%. The percentage of students taking the ACT/SAT is approximately 97.6% of juniors and seniors. The percent of students who have taken at least one dual credit class is 95.4%. Post-Secondary Readiness percentage was at 87%. TSI percentage for both ELA and Math is 57% among seniors and 34% among juniors. .
