Proposals will be opened at the RCISD Central Office upon receipt. RCISD Board Approval is anticipated September 18th, 2023.

As provided by law, the District will consider the following in selecting a vendor: in determining to whom to award a contract, the district shall consider:

- 1) the purchase price;
- 2) the reputation of the vendor and of the vendor's goods or services;
- 3) the quality of the vendor's goods or services;
- 4) the extent to which the goods or services meet the district's needs;
- 5) the vendor's past relationship with the district;
- 6) the impact on the ability of the district to comply with laws and rules relating to historically underutilized businesses;
- 7) the total long-term cost to the district to acquire the vendor's goods or services;

- 8) for a contract for goods and services, other than goods and services related to telecommunications and information services, building construction and maintenance, or instructional materials, whether the vendor or the vendor's ultimate parent company or majority owner:
 - a) has its principal place of business in this state; or
 - b) employs at least 500 person in this state; and
- 9) any other relevant factor specifically listed in the request for bids or proposals.
